Summary: Under the direction of the SUD Services Manager and the Director of Children & Family Services, the SUD Counselor facilitates the provision of substance use disorder treatment services by providing assessment, counseling, treatment planning, crisis intervention, and case management services. Performance is reviewed on a continuous basis with specific goals and objectives identified throughout the year. This is a full-time, non-exempt position working 40 hours per week, Monday through Saturday.

Duties / Responsibilities:

- **Provide counseling and support services by:**
 - Conducting intake and assessment of clients.
 - Developing individualized treatment plans.
 - Conducting individual and group counseling.
 - Providing case management services including assisting clients with Medi-Cal enrollment if needed.
 - Accurately and timely documenting case records, statistical and other administrative data in accordance with all agency requirements.
 - Providing linguistically and culturally appropriate services to clients of diverse backgrounds.
 - Participating in ongoing individual and/or group supervision based on level of skill and professional development.
 - Providing a minimum of 60% direct clinical service hours using the most appropriate intervention modalities; when necessary, providing outreach and case management services and linking clients to community resources.
 - Providing unit support by conducting screenings and language support.
- **Attend relevant meetings, trainings, events and activities:**
 - Attending relevant contract meetings.
 - Attending monthly unit meetings.
 - Attending monthly and quarterly staff/agency meetings.
 - Attending professional development trainings, conferences, workshops and seminars in order to maintain and improve professional competence as assigned by the supervisor.
- **Perform other related duties as assigned by the SUD Services Manager.**

Minimum Requirements / Qualifications (All applicants MUST meet the minimum qualifications):

- Current certification for substance abuse counseling (e.g. CCAPP, CADTP).
- A minimum of two(2) years supervised experience working in substance abuse and/or related field.
- Demonstrable working knowledge of the use and operation of personal computers.
- Bilingual capacity in Korean/English and/or Spanish/English.
- Ability to organize and prepare documentation in an accurate and timely manner using the EHR systems.
- Strong interpersonal, organizational, and written and oral communication skills.
- Ability to work collaboratively with others a willingness to participate fully in the team process.
- Strong commitment to working with a diverse, multicultural organization and community.
- Self-directing and the ability to work independently as required.

- Proof of passing a TB test and Live Scan fingerprinting clearance.
