Summary: Under the direction of the Rise Program Lead, the Youth Services Instructor is responsible for the supervision, facilitation, coordination, and implementation of academic support services and enrichment activities for 6-12th grade students in KYCC's RISE Youth Program, held at KYCC's Menlo Family Center (1230 Menlo Ave). Performance is reviewed on a continuous basis with specific goals and objectives identified throughout the year. Some evening and weekend hours may be required for special events but working days will generally be Monday-Friday. This is a full-time, non-exempt position, working 40 hours a week. Some evening and weekend hours may be required for special events. **(Some duties may not apply due to COVID-19.)**

Duties / Responsibilities:

- **Coordinate and facilitate academic and enrichment services for middle and high school-aged youth by:**
 - Providing instructional activities, homework assistance, and support to youth.
 - Supervising participants to ensure safety and quality of services.
 - Coordinating and facilitating academic and extracurricular enrichment services.
 - Developing and implementing lesson plans.
 - Utilizing agency curriculum as assigned.
 - Overseeing classroom management and classroom volunteers.
 - Communicating with parents regarding student achievement and progress.
 - Transporting youth utilizing agency vehicles.
 - Reporting to the Supervisor on progress.
- **Prepare and submit assigned internal and contractual monthly reporting in a timely manner by:**
 - Monitoring, reporting, and documenting participant and/or program performance.
 - Recording participant attendance.
 - Correcting student assessments and logging performance.
 - Preparing and submitting internal unit monthly reports.
- **Provide responsible handling of agency vehicle and transportation of school-aged children by:**
 - Driving/abiding by all California State vehicle laws.
 - Driving route from/to KYCC site to/from outing/event sites – picking up and dropping off student passengers at established stops on the route.
 - Performing pre and post trip inspections of vehicle to ensure that vehicle is road-worthy and that all safety devices (i.e. seat belts) are in good working order.
 - Attending and participating in safety meetings.
- **Attend relevant meetings, trainings, events and activities.**
- **Perform other related duties as assigned by the RISE Program Lead and/or Youth Services Manager.**



Minimum Requirements / Qualifications (All applicants MUST meet the minimum qualifications):

- Some college experience/credits AND one(1) year experience working with youth in academic settings.
- Knowledge and/or instructional (classroom) experience in working with children, adolescents, and families from various socio-economic and cultural backgrounds.
- Knowledge and/or instructional experience in the operation of summer program(s) and/or after-school program(s).
- Ability to organize and prepare documentation in a timely manner.
- Strong commitment to working with a multicultural community.
- Demonstrable working knowledge of the use and operation of personal computers.
- Strong organizational, written, and communication skills.
- Ability to work collaboratively with others and a willingness to participate fully in the team process.
- Self-directing and the ability to work independently as required.
- Proof of passing a TB test and fingerprinting clearance (Live Scan).
- A valid Class C and/or Class B California Driver's License, access to a personal automobile and proof of auto insurance.
- Physical requirements: seeing to observe and supervise children and to inspect documents; hearing a child calling for help; ability to communicate with KYCC staff, clients and public; sitting and standing for extended periods of time; bending, kneeling and reaching to retrieve and replace files; and dexterity of hands and fingers to operate office equipment.

Desired Qualifications:

- Certification in CPR and First-Aid Training.
- Bilingual Capacity in English/Korean AND/OR English/Spanish.
