Summary: The SUD Counselor II facilitates provision of Substance Use Disorder treatment services by providing assessments, counseling, treatment planning, crisis intervention, and care coordination of services. The SUD Counselor II is a direct service position and works under the direction of the Recovery Services Manager. Performance is reviewed on a continuous basis with specific goals and objectives identified throughout the year, including revenue generation goals. This role requires being full-time in the office.

Required schedule for this position is Monday to Friday:

- ➤ Monday, Wednesday & Friday: 9:00 a.m. 6:00 p.m.
- ➤ Tuesday & Thursday: 12:00 p.m. 9:00 p.m.

Some weekends may be required with advanced notice.

Duties/ Responsibilities:

• Provide counseling and support services by:

- Conducting intake and assessments of clients;
- Developing individualized treatment plan;
- o Conducting individual and group counseling;
- Conducting toxicology screenings including Recovery Incentive Program/Contingency Management service;
- o Provide care coordination services;
- Accurately and timely documenting case records, statistical and other administrative data in accordance with all agency requirements;
- o Providing linguistically and culturally appropriate services to clients of diverse backgrounds;
- o Participating in ongoing individual and/or group supervision based on level of skill and professional development;
- o Providing engagement and outreach;
- o Providing unit support by conducting screenings and language support.

• Attend relevant meetings and trainings:

- Attend relevant contract meetings;
- o Attend individual and group supervision meetings;
- O Attend monthly and quarterly staff/agency meetings; and
- Attend professional development trainings, conferences, workshops and seminars in order to maintain and improve professional competence as assigned by the supervisor.

Minimum Requirements / Qualifications (All applicants MUST meet the minimum qualifications):

- Current certification for substance abuse counseling (CCAPP, CADTP, or CAADE);
- Minimum five years of supervised experience working in substance abuse and field;
- Experience in providing Drug Medi-Cal contract services including ASAM assessments, Motivational Interviewing, and Cognitive-Behavioral Therapy;
- Demonstrable working knowledge of the use and operation of personal computers;
- Ability to organize and prepare documentation in a timely manner using the EHR systems;
- Strong interpersonal, organizational, written and communication skills;
- Strong commitment to working with a multicultural community;
- Ability to work collaboratively with others and a willingness to participate fully in the team process;
- Self-directing and the ability to work independently as required.
- A valid Class C California Driver License, personal automobile, and proof of auto insurance; and
- Proof of eligibility to work in the United States.
- Ability to Work 100% in-person requiring daily attendance at the office or designated work location and the ability to mobilize for outreach purposes as needed.
- Physical requirements: Seeing to inspect written documents; ability to communicate with KYCC staff, clients and public; sitting for extended periods of time; bending, kneeling and reaching to retrieve and replace files; and dexterity of hands and fingers to operate office equipment; and ability to lift up 40 lbs.

Desired Qualifications:

- Bilingual capacity (Spanish/English or Korean/English)
- Experience in Recovery Incentive Program/Contingency Management service.
- Certification in CPR and First-Aid training.
